## Reflective Practice and Parallel Process in Clinical Supervision – Master Class

### Facilitator: Christine Senediak

This 1-day Master Class covers the theory and practice in how to apply reflective practice within a competency-based supervision framework. Participants will develop meta-competencies for setting up, facilitating and evaluating supervisee reflection. The workshop will provide a clear framework in how to apply reflective practice and provide effective feedback and evaluation in supervision. Various supervision tools will be provided and demonstrated in alliance building and role induction for reflective practice. Pre-reading resources are provided, including revision notes and a Supervision Resource Handbook of core supervisory practices within a competency framework. The workshop will include live demonstrations, review of video examples, interactive didactic presentation and experiential peer group activities. For psychologists with AHPRA registration, participants can apply for Master Class supervisor accreditation by completing this workshop. Places strictly limited.

Once completed, participants can apply to AHPRA for supervisor accreditation effective for 5 years. The 3 components of training include: Online theory Knowledge Assessment (online self-paced study - must be completed prior to workshop); 2-day workshop (face to face skills-based workshop); Video competency-based assessment submission (due within 6 months of workshop dates). Certificates provided: Participants receive certificates for Part 1, Part 2 and Part 3 of the AHPRA PsyBA Full Supervisor Training.
